**ORDER**

Government vide Order read as 1<sup>st</sup>paper above accorded Administrative Sanction for 'Construction of Ramanattukara Municipal Office Building' using KIIFB fund. Managing Director Impact Kerala Ltd vide letter read as second paper above informed that the financial bid for the work was opened in May 2021 and the bidder M/s Nirman Constructions has quoted an amount of Rs.11,44,98,821.06 + 12% GST, which is 13.55% above the TS amount of Rs.10,08,35,165.00 + 12% GST.

The bid was placed before Tender Acceptance Committee of IMPACT Kerala Ltd in its meeting held on 14.07.2021 and the Committee observed that

1. The quoted amount of Rs.11,44,98,821.06 + 12% GST, which is 13.55% above the TS Amount is obtained in retender.

2. Since the quoted amount is within the LMR amount and further reduced quote is unlikely to be obtained, the current quoted amount



can be accepted.

3. Since the quoted amount of the project is more than 10% of the TS amount, the project shall be submitted to the Administrative Department for approval

On the basis of Clause 7.2.4 of the Order read as third paper above and the recommendation of Tender Acceptance Committee , Managing Director, IMPACT Kerala Ltd, requested the Government to approve the tender as the quoted rate is more than 10% above.

Government have examined the matter in detail and are pleased to approve acceptance of the tender quoted by the bidder M/s Nirman Constructions for the work 'Construction of Ramanattukara Municipal Office Building' at the quoted rate of Rs.11,44,98,821.06+12% GST , which is 13.55% above the TS amount.


